BIOGRAPHIES - PRESENTERS AND GUESTS

THE REV. DR. MATTHEW C. HARRISON



The Rev. Dr. Matthew C. Harrison, the 13th man to serve as President of The Lutheran Church—Missouri Synod (LCMS) since its founding in 1847, is the church's chief ecclesiastical officer, supervising the doctrine taught and practiced by its nearly 9,000 ordained ministers; representing the LCMS with its partner church bodies throughout the world; and overseeing all officers, executives and agencies of the LCMS. He was first elected to the office of LCMS President in 2010 and was re-elected in 2013.

Harrison joined the staff at the LCMS International Center in St. Louis in 2001 as the Executive Director of the church's former World Relief and Human Care ministry. During that time, he oversaw the church's multimillion-dollar responses to epic disasters, including Hurricane Katrina, the Asia tsunami and the Haiti earthquake; managed relationships

with some 120 LCMS Recognized Service Organizations and other inter-Lutheran social ministry organizations; worked in consultation with LCMS partner/sister churches to build capacity during mercy outreach efforts; and managed the church's global pro-life efforts.

Previously, Harrison served as a pastor at St. Peter's Lutheran Church in Westgate, lowa (1991-1995), and Zion Lutheran Church in Fort Wayne, Indiana (1995-2001). During his pastorate at Zion in Fort Wayne, his parish embarked on the St. Peter/Zion Project for Neighborhood Renewal, a now nationally recognized neighborhood revitalization effort. Owing to the success of this effort, Harrison later founded Lutheran Housing Support Corporation, a faith-based housing organization headquartered at the LCMS International Center that helps revitalize communities and renew neighborhoods across the country.

Harrison graduated with a bachelor's degree in religious studies from Morningside College in Sioux City, Iowa, in 1984. Following his graduation, he and his wife, Kathy, spent a year as missionaries in a remote Canadian Cree Indian village with the Lutheran Association of Missionaries and Pilots. Harrison went on to earn a Master of Divinity in 1989 and a Master of Sacred Theology in 1991, both from Concordia Theological Seminary, Fort Wayne. He has pursued additional graduate study at Concordia Seminary, St. Louis. In 2011, he received two honorary doctorates: a Doctor of Laws from Concordia University, Ann Arbor, Michigan, and a Doctor of Divinity from Concordia Theological Seminary, Fort Wayne.

Before being elected president, Harrison served on a number of boards for church and community organizations. He is a prolific writer whose books include *A Little Book on*



Joy, a devotional-style book about finding delight in living a Christ-centered life in today's society, and Christ Have Mercy: How to Put Your Faith in Action, a book urging Christians to consider the innumerable opportunities they have to show mercy to fellow Christians and to anyone God places in their path. He compiled and translated At Home in the House of My Fathers, a collection of works by several of the church's founders, and edited The Lonely Way: Selected Essays and Letters by Hermann Sasse, a prominent confessional Lutheran theologian in the German ecumenical movement of the early 20th century. Most recently, Harrison revised and edited a new edition of C.F.W. Walther's The Church and the Office of the Ministry a seminal writing by the first president of the LCMS, and translated Letters to Lutheran Pastors — Volume 1, Volume 2 and Volume 3, an edition of Sasse's correspondence with Lutheran pastors around the world.

Harrison and his wife live in Ballwin, Missouri, and are members of Village Lutheran Church in Ladue, Missouri, where Harrison also serves as assistant pastor. They have two sons. Harrison is an avid banjo player and instrumentalist who makes guitars, banjos and mandolins.

THE REV. DR. ROBERT J. SCUDIERI



Bob Scudieri was born on October 8, 1944 in Queens, New York, where he attended public schools. In 1967 Scudieri married his Concordia, New York college sweetheart, Lynn Gollenberg. Over the years two wonderful children, Nathan and Alison, followed.

After graduating from Concordia Seminary in 1971 he served full time as a Lutheran pastor for thirty-eight years: he was a parish pastor, the Mission Executive for the English District of the Lutheran

Church, and for the last eighteen years of his ministry he was the head of missions in North America for his denomination. During that time half of all new church starts were among refugees and immigrants. Many Korean, Indian, Chinese, Hispanic, African, Japanese, blind, deaf, Jewish, Pakistani and Hmong leaders and congregations owe their membership in the Synod to the work of Dr. Scudieri.

He was also one of the founders of the Center for US Missions, an organization that interviews and prepares church planters. He began Open Arms Child Development Centers (starting over 60 Christian day care centers), the Lutheran Society for Missiology (publisher of the journal *Missio Apostolica* – now, *Lutheran Mission Matters*), and a National Missions Advisory Board. During his time as head of national missions, the Transforming Churches organization was begun.

In 1991, he wrote the book, *Apostolic Church: One, Holy, Catholic and Missionary* – a book on missions used by various seminaries. In 2012 a Metropolitan of the Georgian Orthodox Church read a Russian translation of the book and invited Dr. Scudieri to be a presenter at an ecumenical conference in Tbilisi, Georgia.

In 2010 Dr. Scudieri retired, and he and his wife Lynn moved to Florida. For three years Bob served Faith Lutheran Church, Naples, part time, as their Mission Equipping Pastor. In that role he helped start the Muslim mission, Voice of Faith and the Spirit of Naples film production studios. In retirement, Pr. Scudieri continues to serve on several national boards.

In 2014 he began Mission Nation Publishing, a company that gives a voice to missionaries to America. The books published by Mission Nation tell the stories of courageous immigrant leaders who are risking their lives to come to the United States to strengthen the church in America. The website (www.MissionNationPublishing.org) has more than sixty video interviews of missionaries to America, mission books for sale and resources for those with the opportunity to reach refugees and immigrants in the US.

THE REV. CHRISTOPHER S. ESGET



The Rev. Christopher S. Esget is sixth vice-president and a member of the Praesidium of The Lutheran Church—Missouri Synod (LCMS). He was appointed to the position in 2015, and was elected at the 2016 convention. He represents the church's East-Southeast Region.

Esget is the senior pastor of Immanuel Evangelical-Lutheran Church in Alexandria, Virginia, and superintendent of Immanuel Lutheran School, where he has served since 2001.

Prior to being called to Immanuel, Esget served as pastor of Bethel Lutheran Church, DuQuoin, Illinois, where he was ordained in 1998. He attended Concordia Theological Seminary, Fort Wayne, Indiana, where he earned a Master of Divinity in 1997 and a Master of Sacred Theology in 2005. He is a member of the Board of Regents for Concordia College—New York.

He is the author of "Saints and Faithful Brothers" and "The Gates of Hell and the Table of the Lord" in *The Gates of Hell: Confessing Christ in a Hostile World* (CPH 2018). Esget's writings have also been published in *The Lutheran Witness, Concordia Pulpit Resources, The Good Shepherd Institute, For the Life of the World, Higher Things*, and *Gottesdienst*. He is a 2015 Washington Fellow of the National Review Institute.

Born and raised near Minneapolis, Esget pursued his love of music with classical piano and trombone studies at the University of Minnesota before graduating summa cum laude with a bachelor's degree in music from the Berklee College of Music in Boston in 1993.

Esget and his wife, Kassie, live in Alexandria, Virginia. They have one son, James.

THE REV. DR. JON D. VIEKER



The Rev. Dr. Jon D. Vieker is Senior Assistant to Rev. Dr. Matthew C. Harrison, President of The Lutheran Church—Missouri Synod.

Prior to joining the President's staff in September 2010, Vieker served as Assistant Director for the LCMS Commission on Worship, a position he began in November 1998. In that position, he was involved with all aspects of research, development, editing and production of *Lutheran Service Book* and its core companion volumes.

A native of Livingston, California, Vieker received a B.A. in music from California Lutheran University, Thousand Oaks, California, and M.Div., S.T.M. and Ph.D. degrees from Concordia Seminary, St. Louis, Missouri. Vieker's area of academic interest is the history of American Lutheranism, specifically as viewed through its hymnals and hymnody and the wider American ecclesial context.

Vieker has served as editor for a number of publications, including *Festschrift* volumes in honor of Norman Nagel and Ronald Feuerhahn and *Through the Church the Song Goes On*, a collection of essays published by the LCMS Commission on Worship. He has also written a variety of articles on Lutheran hymnody and liturgy and is a composer with choral settings and organ preludes published by Concordia Publishing House and Liturgy Solutions.

Prior to serving with the LCMS Commission on Worship, Vieker was a parish pastor for nine years at St. Mark's Lutheran Church, West Bloomfield, Michigan. He has also served as organist and choir director in a variety of settings.

Vieker and his wife, Kim, live in Manchester, Missouri, and are members of St. Paul's Lutheran Church in Des Peres, Missouri, where they serve in the parish choral and instrumental ensembles. They have two grown children.



PARLIAMENTARY PROCEDURES - A PRIMER

Purpose of Parliamentary Law and Procedure

Parliamentary procedure assists a deliberative and decision-making assembly in carrying out its purpose and aims in an orderly, fair, and expeditious manner.

It is not the purpose of parliamentary procedure to make the conduct of business in an assembly difficult, to entangle an assembly in technicalities, or to provide a channel for individuals to flaunt their parliamentary knowledge.

Parliamentary law protects six basic rights:

- 1) The right of the majority to make a decision;
- 2) The right of the minority to be heard in hopes that it may become the majority;
- 3) The right of absentees to be protected;
- 4) The right of the assembly to be comfortable and to hear;
- 5) The right of the individual member to be honored;
- 6) And the orderly consideration of one subject at a time.

Basic Steps of Handling a Motion

The chairman and members of the assembly should be acquainted with and observe eight basic parliamentary steps to take care of convention business in an orderly and fair manner. They are:

MEMBERS:

- 1) Address the Chair. "Mr. Chairman" (or Mr. President)
- 2) Await recognition by the Chair.
- 3) Make the motion. "I move that..."
- 4) Second the motion. (Unless not required)

CHAIR:

- 5) States the motion. (Or rules it out of order)
- 6) Calls for discussion. (Unless motion is un-debatable)
 "Is there any discussion?" or "Are there any remarks?"

 Ample opportunity must always be given for expression of opinion and for discussion.



- 7) Takes the vote. (Or "Puts the question")
 First calls for the affirmative vote, then the negative. "Those in favor of the motion say 'aye'; those opposed say 'no'." (A tie vote defeats the motion, since a majority is required to adopt unless the motion requires a 2/3 vote.)
- 8) States the results.

"The 'ayes' have it and the motion is carried." Or, "The 'no's' have it and the motion is lost." The vote does not go into effect until the results are announced.

Basic Parliamentary Principles for the SED Convention

- A district delegate convention is a parliamentary assembly called to deliberate and to make decisions. It receives the reports of the District President and the Board of Directors. In addition, the convention deliberates and makes decisions on recommended resolutions of designated floor committees which have considered proposed resolutions (overtures) from congregations.
- 2. All voting delegates have equal rights, privileges, and obligations.
- 3. The vote of the majority decides. The will of a district convention is determined by the taking of a vote.
- 4. Free discussion of every proposition or resolution presented for decision is an established right for all delegates, voting and advisory. To accomplish the closure of debate a delegate must gain the recognition of the chair and, without any comment for or against the pending resolution, say, "I move the previous question." If seconded, this motion is put to an immediate vote. If adopted by a two-thirds vote, discussion is finished and the pending resolution is put to the assembly without further debate. The convention has the right to decide when it has heard sufficient discussion. This right, however, should be exercised with restraint.
- 5. Both proponents and opponents of the given proposal have rights which must be safeguarded. The decision belongs to the majority, but the right to discuss, the right to be heard, and the right to oppose should be upheld. A member of the majority on one question is often a member of the minority on another.
- 6. The simplest and most direct parliamentary procedure for accomplishing a purpose should be followed rather than taking devious routes and multiplying technicalities.
- Every delegate has the right to know what question is before the convention and what its effect will be, for every action taken by a deliberative body should be taken knowledgeably.
- 8. Voting delegates are not bound and are not to be bound by previous instructions of their home or neighboring congregations.



PROPOSED STANDING RULES

- 1. Members of the Convention asking for the floor shall state their names. They also shall state the name of the congregation or the administrative unit they represent.
- 2. Instead of only a voice vote on motions before the convention, the chair shall ordinarily also call for the raising of the right hand, or the use of an electronic audience response system.
- 3. Questions of privilege shall ordinarily be addressed in writing to the chair, or its appointee, instead of consuming convention time.
- 4. Resolutions prepared by the floor committees which are not acted upon by the convention before adjournment die. The subject matter may be reintroduced at the next convention by means of an overture.
- 5. Unless covered by these standing rules of the convention, parliamentary procedure shall be governed by the current edition of Robert's Rules of Order Newly Revised.
- 6. When speaking to the question on the floor, a delegate shall attempt to speak directly for or against the question. When the chair notes that there are many delegates waiting to speak to a given question, the chair may, at his discretion, invoke a three-minute speaking rule. The chair shall notify the assembly when this rule becomes effective.
- 7. Lay Members of the Southeastern District Board of Directors and the Lay Executives shall be accorded the privilege of voice on the floor of the Convention.
- 8. All cellular phones and other communication devices that send or receive an electronic signal must be placed in "airplane mode" during elections.
- The Floor Committee Chairperson or representative may be given opportunity to provide background information or rationale for the respective Floor Committee's work on resolutions prior to presenting the resolution for consideration by the delegates.
- 10. If a substitute motion is offered and seconded, the presenter shall be offered two minutes to provide the rationale for offering it, after which the convention shall decide by majority vote without debate whether or not to consider the substitute. If the decision is in the affirmative and if the substitute motion is subsequently adopted, the original motion fails. If the substitute motion does not receive favorable action either to consider or to adopt, the original motion is again considered. (This is the so-called "Behnken Rule" for addressing substitute motions.)
- 11. Nominations from the Floor: A nomination may be made from the floor during specific time periods of the Convention as outlined in the Agenda. Unless the



convention decides to do otherwise by majority vote, only names submitted prior to the published deadline for submission of names (December 18, 2017) will be eligible for nomination from the floor. At the time of nomination, completed consent and biographical data forms must be submitted to the Secretary of the District.

Please keep in mind that these keypads have a replacement value of \$100.00 and the District will be responsible for replacing any lost units. Please use care not to misplace the unit while the keypad is in your possession. Each keypad has a distinctive identifying number. This number will be signed out under your name.
